

UK readers will certainly recall instances when there has been a tug of war, so to speak, between decisions of the courts and the will of parliament. â Â[^]I have long been of the opinion. â Â[™] says Waltman in the preface. â Â^tthat the modern Supreme Court has assumed too large a role in our political life.â Â[™] He therefore calls for â Â^a theory of constitutional government, rather than $\tilde{A} \notin \hat{A}$ a set of prescriptions for the Court $\tilde{A} \notin \hat{A}$ \hat{A}^{TM} . The stated aim here is to set out just such a theory in this book. The result is a rather fascinating read which, among other things, sheds considerable light on the salient points, as well as the nooks and crannies of the American Constitution. The core of the book is the fourth chapter on A¢A A^A Constitutional Theory of Judicial Restraintâ Â[™] which commences with commentary on the maladies of judicial activism â Â^especially the stentorian form that it has taken under the current Court.â Â™While a heightened judicial role could be appropriate and necessary in certain circumstances enumerated in the text, basically what is needed, says Waltman, is â Â^a constitutional and judicial philosophy that includes judicial review, but simultaneously grants a healthy respect for how people wish to govern themselves. $\tilde{A}c\hat{A} \hat{A}^{TM}$ Now who could or would disagree with that, except a particularly â Â^stentorianâ Â™ or dictatorial judge?As a clearly argued and thoughtful exploration of this and other issues worthy of urgent examination, this book -- which is available online as well as in hardback -- is quite a find.
