It is super heavy and thick. A lot of people in my class just tore it into individual pieces. I don't like to destroy books, so I just carried this hunk of junk around campus everyday--what a pain in the *&#*, Also, almost all of the contents are available for free online (albeit spread out and in multiple editions). Typical legal scholar--copy a bunch of stuff from the free domain, put it in a book, and charge law students up the &#* for it. Thanks.

I bought this because it is required for my corporations class; but it will be useful in practice too. My only complaint is that the cover is very flimsy so it's easy to damage. Superficial complaint. It's voluminous so it pays to tab the important pages and divide the sections for easy reference. I prefer this to other collections of corporate legislation because it contains most of the text instead of just excerpts that the editor considers to be important - context can be important.

Kinda antiquated given you can get all these rules online or through westlaw or lexis. It's just easier than carrying around this dense book. Can't tell you if Bloomberg has the rules; I hate that website.
