

The emphasis on analogical reasoning and synthesizing cases, as well as rule-based and policy-based reasoning, with explanations of how to use these types of reasoning to organize a legal discussion. Numerous examples and frequent short exercises to encourage students to apply concepts. Many exercises focus on first-year courses and others focus on professional responsibility.
