

Synopsis

This concise casebook offers materials that are thorough yet brief, enabling coverage of all the major topics in a three- or four-credit format. The emphasis is decidedly on primary materials: well-edited principal cases, followed by notes that inform the student on important details and developments. Each chapter covers an article of the Federal Rules of Evidence. Within the chapters and sections, the materials generally follow the sequence of the Rules. The 7th edition covers all important recent developments, including federal and state court decisions interpreting the Rules, the 2014 addition of Rule 801(d)(1)(B)(ii), recent Supreme Court Confrontation Clause decisions such as Williams v. Illinois and Ohio v. Clark, and state and lower federal court interpretations of them.

If you are a law student (who else would buy this) and you have to use this text, well you are in luck. This book, accomanied by a copy of the federal rules will be all that you need in the study of evidence. This text isnt like most books on evidence, there are no problems, only cases and notes. The cases correspond to specific rules in the Federal Rules and help explian how each rule works. Also the notes expand on the rule to show how it would it apply in other contexts. Also if you are in a TX law school, this book will also help to illustrate some of the key difference in the federal rules and the Texas state rules (i.e. statement against interest hearsay exception). All in All this is a great text.

Any case law book by West is the premier choice for law schools and professors. The function of a casebook is to provide case materials, summaries, judicial opinion, dicta, citation, etc. It's a teaching tool in law school just as a frog is a teaching tool in a biology class. The frog doesn't spoon-feed answers to the student, and neither does the casebook. Answers in law school are the responsibility of the student. A good law professor doesn't provide the answers, but rather the professor provides the questions in classical Socratic method. West is the gold standard, and there's a reason for that.

This casebook contains too many cases involving objectionable subject matter (e.g., child sexual abuse). Illustrative cases with less shocking content could be found. My daughter is very curious about my studies and would love to read my books, but I had to keep this one out of reach.
