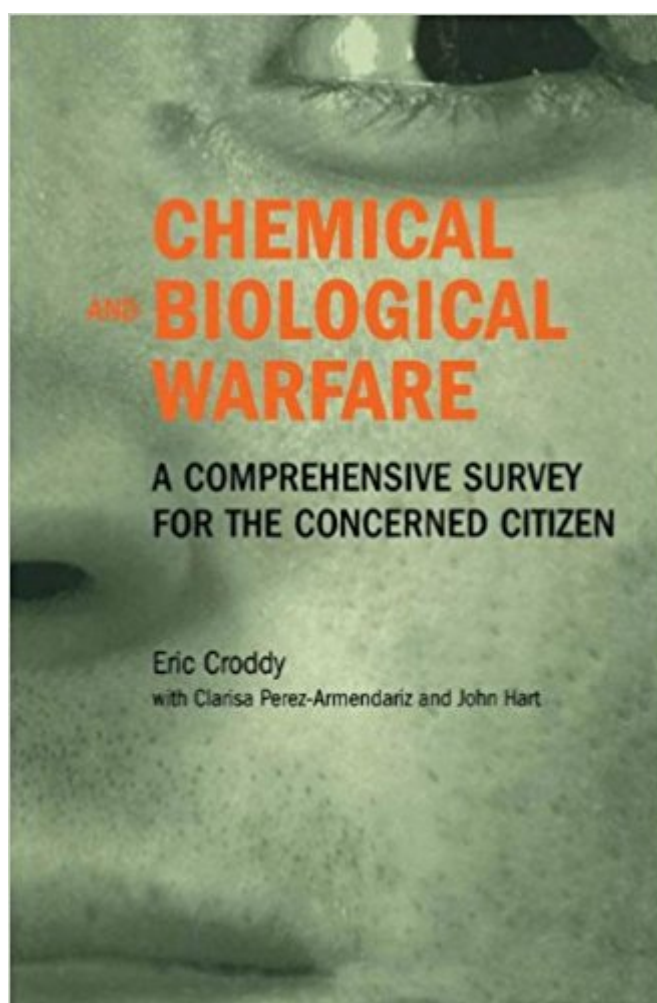

Chemical And Biological Warfare: A Comprehensive Survey For The Concerned Citizen



Synopsis

The armaments of chemical and biological warfare (CBW) are now widely held not just by nation-states, but by terrorist and criminal enterprises. The weapons themselves are relatively inexpensive and very easy to hide, allowing organizations of just a few dozen people to deploy potentially devastating attacks. While in the twentieth century most arms-control efforts focused, rightly, on nuclear arsenals, in the twenty-first century CBW will almost certainly require just as much attention. This book defines the basics of CBW for the concerned citizen, including non-alarmist scientific descriptions of the weapons and their antidotes, methods of deployment and defensive response, and the likelihood in the current global political climate of additional proliferation.

He describes the various existing chemical and biological weapons, how they work, and which countries own them, evaluating the threat that each kind of weapon poses and the likelihood of its use. There's a great deal of information in this book but it's a bit poor in terms of writing style, felt like I was reading someone's term paper on CBW. Well researched and referenced but also lacking from adequate editing for typos and things like that.

I read, and enjoyed, Judith Miller's *Germs* book, but its sometimes superficial journalistic treatment left me wanting more concrete information: on chemical and biological agents, where they come from, who has them, how they could get used, what we can do to stop or counteract them, etc. I found all that and more in this excellent book, which, in spite of its straightforward presentation, is every bit as gripping as *Germs*. Croddy is no alarmist---he thinks a lot of the recent hoopla is overblown given the difficulties any terrorist would have spreading an agent like anthrax (and, thank God, he appears to be right on this score)---but there's plenty to get alarmed over in this book, and now is the right time to read it and digest its lessons, rather than waiting for the next chemical or biological panic attack.
