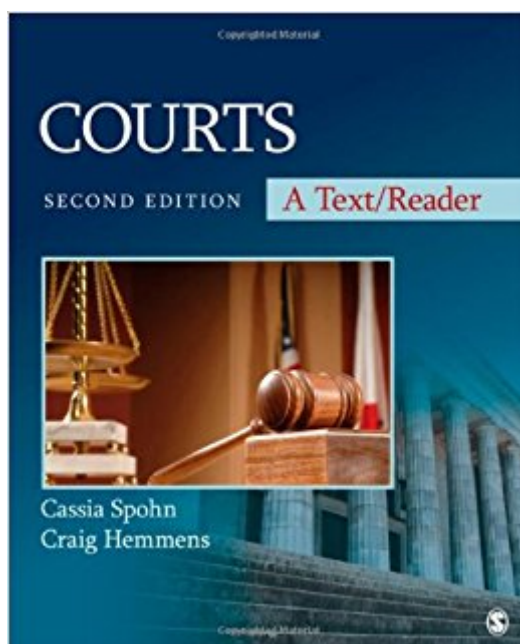

She is the author or coauthor of six books, including Policing and Prosecuting Sexual Assault: Inside the Criminal Justice System, which was published in 2013. Her research interests include prosecutorial and judicial decision making, the intersections of race,

ethnicity, crime and justice, and sexual assault case processing decisions. In 2013 she received ASU's Award for Leading Edge Research in the Social Sciences and was selected as a Fellow of the American Society of Criminology. Craig Hemmens is a professor in the Department of Criminal Justice and Criminology at Washington State University. He holds a JD from North Carolina Central University School of Law and a PhD in criminal justice from Sam Houston State University. He previously served as department head of the Department of Criminology and Criminal Justice at Missouri State University and as chair of the Department of Criminal Justice, director of the Paralegal Studies Program, and director of the Honors College at Boise State University. Professor Hemmens has published 20 books and more than 100 articles on a variety of criminal justice topics. He has served as the editor of the Journal of Criminal Justice Education.
