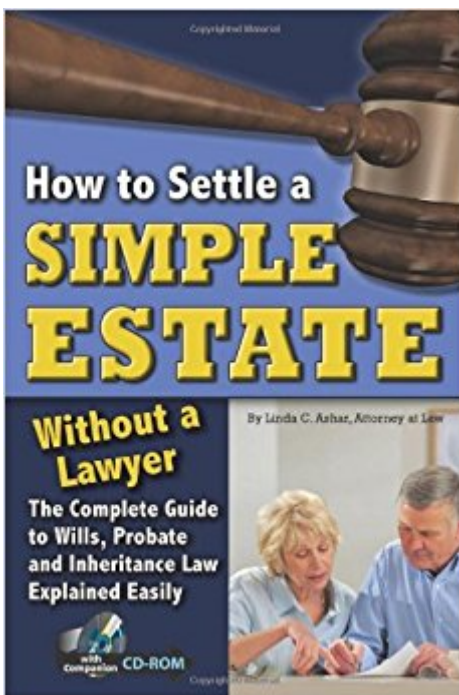

The Estate I am helping with is very simple, with 1 beneficiary who is also the Executor. You must refer to your own State Laws for the specifics. For example, in PA the Executors Notice must appear 3 times in a publication which covers the decedents residential location. Most Court Houses will give you a packet of Forms to complete. These forms also have instructions. I checked everything mentioned back to my State and my accountant. I fully expect to be able to close the Estate without the need for a lawyer, but if you are not sure about anything consult legal help on an hourly basis. I did not hand the Estate over to be managed by a lawyer due to the expense. Just employ them for the specific need and get a fee for that work.
