

Good reference. Couple mistakes on how many justices dissented. I wish the facts of the case were more clearly written with more details. Also when referencing a case that overturned a case, it would be helpful if all cases were actually written in the book.

The content of the book is great, though they are missing some fairly essential cases, such as Cruzan v. Director, Missouri Department of Health and Whitney v. California, as well as around a dozen others. A number of pages were not successfully bound and started falling out after the second day of use. I would buy the book again, or anything else from the author, but the publisher's work is left wanting. Not good for use in school where it would be heavily used.
